

## **TERMS AND CONDITIONS OF USE**

### **AGREEMENT BETWEEN USER AND THE SALISBURY FIRE DEPARTMENT**

The Salisbury Fire Department Web Site is comprised of various Web pages operated by the Salisbury Fire Department.

The Salisbury Fire Department Web Site is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein. Your use of the Salisbury Fire Department Web Site constitutes your agreement to all such terms, conditions, and notices.

### **MODIFICATION OF THESE TERMS OF USE**

The Salisbury Fire Department reserves the right to change the terms, conditions, and notices under which the Salisbury Fire Department Web Site is offered, including but not limited to the charges associated with the use of the Salisbury Fire Department Web Site.
